OCSL has the experience of dealing with many types of corporate entities, in multiple jurisdictions, including SPVs that have been used for investment segregation, e-gaming, real estate holding, aircraft leasing, yacht management, forex services, crowd-funding and other types of business activity.

As our CEO is a highly experienced fiduciary, we also deliver fiduciary consultant services to boutique trust groups and family offices who wish to offer trust and/or foundations, to their clients, but are disinclined to hire a high-cost trust lawyer. Nevertheless, OCSL does not offer trustee services directly, as that would be a conflict of interest for our trust group clients. So, we offer professional protector services instead, to both trusts and foundations, in order that trustees, foundation councils, settlors, founders, and beneficiaries can all benefit from the extensive fiduciary experience, which our CEO has accumulated.

Our trust/foundation services include the following:

- Trust/foundation establishment advice;
- Trust deed and supporting document drafting and/or review;
- Advice on trust/foundation administration issues;
- Rectification advice for defective or problem trusts or foundations.

OCSL also assists with opening bank and investment accounts, for corporate entities and individuals, and we can fully advise on FATCA and/or CRS reporting issues when required to.
